PRELIMINARY STATEMENT

A. By merger effective June 30, 1978, MONUMENTAL

PROPERTIES, INC., a Maryland corporation, merged into MONUMENTAL

CORPORATION, a Maryland corporation. Effective July 1, 1978,

MONUMENTAL CORPORATION pursuant to a plan of partial liquida
tion, transferred beneficial title to part of its assets,

including the property affected by this Assignment, to MONUMENTAL

PROPERTIES TRUST.

B. Pursuant to the merger and transfer referred in paragraph A above, the Trust and Corporation have succeeded to the rights and obligations of the developer under the Declaration of Covenants, Restrictions and Conditions dated January 20, 1978 by Monumental Properties, Inc., recorded among the Land Records of Anne Arundel County, Maryland, in liber 3051, folio 750, (the "Declaration"), which was made for the purposes of creating and maintaining a general scheme of development by imposing certain covenants and restrictions on the following

real property located in Anne Arundel County, Maryland:

- Lots 56 to 100, Block "B", both inclusive: Lots 55 to 66, Block "A", both inclusive; all as shown on Plat entitled "Plat 1, Section 1, Shipley's Choice", which Plat is recorded among the Land Records of Anne Arundel County, State of Maryland on Plat 3483, Book 66, Page 8.

- 3. Lots 1 to 32, Block "A", both inclusive; all as shown on Plat entitled "Plat 3, Section 1, Shipley's Choice", which Plat is recorded among the Land Records of Anne Arundel County, State of Maryland on Plat 3485, Book 66, Page 10.
- 4. Lots 1 to 32, Block "B", both inclusive; all as shown on Plat entitled "Plat 4, Section 1, Shipley's Choice", which Plat is recorded among the Land Records of Anne Arundel County, State of Maryland on Plat 3486, Book 6, Page 11.
- C. The Declaration provides that the declarant thereunder may assign or transfer any of the rights and powers (including discretionary powers and rights) reserved in the Declaration for the declarant to any one or more corporations or associations agreeing to accept such assignment or transfer.
- D. The Trust and the Corporation, pursuant to the power granted in the Declaration, desire to assign to the Association all of the Trust's and the Corporation's rights and powers (including discretionary powers and rights) under
